- c. CC had received requests for the new date for the West Drove Road repairs, but no updates received to date.
- d. Replacement streetlight still awaiting connection date.
- e. CJ reported that 2 residents on French's Road had reported an increase in HGV's and RG advised this could be down to collections/deliveries to farmers due to the sugar beet collections and should soon be back to normal levels.
- f. HS advised that the repairs/maintenance to the Playground had started this week.

7.2 County and Borough Councillors reports-

RB reported that Borough are busy with budgets which should be decided within the next two months.

7.3 Clerk Report -

Working on the allotments, especially the new small plots. Attended GDPR training updates and training/information the forthcoming elections in May.

Andy Wallace has been chased again regarding the onsite meeting discussed last October.

7.4 Village Crier/social media/Website-

The Clerk advised of an increase in the cost of printing the Crier by 52.00 per issue, bring the total to £473.00. The editor has advised that more advertisers are in the pipeline. Deadline for the next issue will be 16th of January 2023.

CC advised that there was a small increase in hits on the fb page with positive reports on the Christmas Tree Festival.

- 7.6 The Community Fund Projects Working Group Nothing to report.
- 7.7 SAM 2- update from AE re by the school sign 65mph recorded on the 12th December at 12.55pm but the average speed was 25.6. The second unit had to be removed from Church Road due to the pavement works.

Units are not on Walpole Bank and Chalk Road. The Folgate Lane post is in place with the Pyecroft/Chalk Lane post awaiting installation.

7.8 Neighbourhood Plan update – Mr. P Cotton:

Mr. Cotton advised that the uptake of the online survey was poor and stressed all councillors should be completing the survey. He requested a two-week extension to the 26th of January to give more time for residents to complete. This was approved.

Mr. Cotton has been door knocking on Church Road and found that a majority of residents read the Crier when they need local information or advertiser details. RB advised that the various support groups need to help the drive and we do not have a reason to drive it through i.e., a large development.

Mr. Cotton strengthened the need for all parishioners to complete the survey which can be accessed from the Parish council website.

22/02265/FM | Proposed development of an energy storage installation and associated development to allow for the storage, importation and exportation of energy to the National Grid at land opposite Walpole substation, Walpole Bank. This is the 3rd such application and the issues of fire/storage safety etc., as discussed at our December 22 meeting are still very relevant. The landscaping was raised as needs to be high enough to hide the structure from the road and include hedgerows and trees. It would be good to see the 2 previous applications built first to enable judgement to be made. A point was raised that the area was becoming a battery storage dumping ground. Objections proposed regarding fire hazards etc., by CB, seconded CC and all in favour with RG & RB abstaining.
