# **WALPOLE PARISH COUNCIL**

Minutes of the Parish Council Meeting of Walpole Parish Council held at the Parish Hall, on Thursday 3rd of November 2022 from 7.00pm

#### Present:

1. Welcome from Chairman to everyone.

Public Participation – to allow public participation (3 minutes per speaker, up to a maximum of 15 minutes in total). Agenda items only not including planning:

- a. A tenant farmer, Mr. A Thistleton, requested that a stowaway be removed on a field rented from the Parish Council to prevent hare coursing. (Duck point/Marsh Road, Gooses Lane). RG agreed that there was a problem in the area and all councillors were in favour of this action.
- 2. Apologies to accept apologies and reasons for absence: Cllr Lawty illness.
- 3. To remind all councillors of their duty to abide by the Code of Conduct.

  The Chair reminded all councillors of their duty to abide by the Code of Conduct.
- 4. Declarations of Interest of any items on the agenda and to consider any requests for dispensations. None.
- 5. Approval of the Parish Council Meeting held on the 6<sup>th</sup> of October 2022 were proposed by HS, seconded by WB, and approved by all present at that meeting.
- 6. Matters Arising to record matters arising from the last meeting:
  - 6.1 ENSO Energy update CJ advised that she is still awaiting Enso to respond to her requests to arrange an on-site meeting. CL will check the ENSO website for making contact etc.
  - 6.2 Allotment Vacancies The clerk reported that there are now 6 applications for small plots, and it was agreed that plot 27 (0.90 acres) would be the best location to offer smaller plots. Clerk to check on tenancy agreements, rules & regulations etc. Proposed AB, seconded AE and all in favour. ACTION CB WB proposed that plots 24.25 & 26 be offered to Mr. L. Coleman and plots 28-37 be offered to Mr. A Thistleton. This was seconded by HS and 7 in favour with 2 abstains.
  - 6.3 Maintenance required to the play area following annual inspection and overhanging hedging. The clerk had written to the school but no response as yet. CJ & CC will follow this up directly with the school. It was agreed to go ahead with the maintenance work on the play equipment -proposed AE, seconded by CC and all in favour.
  - 6.4 Strimming add to the next agenda.
  - 6.5 Project Swingfield/Almshouses area AB to arrange for quotation from Mr. Neal for next meeting.

  - b. WB asked about when he replacement light would be working and, as advised at the last meeting, we are just waiting for a date from UK Power networks for a connection date. WB asked if anyone knew if the Walpoles was still a joint rural village and the general consensus was thought to be yes. The white gate signage shows The Walpoles.
  - c. AE requested that the gulley cleaner missed the cleaning the gully near his home on Wisbech Road and it was now blocked. Clerk to report.

- 7.2 County and Borough Councillors reports:

**Cllr Kirk** – Advised that the village was known as The Walpoles therefore must be a joint village. The Wild Club CIC email was discussed, and it was decided that there is no available land or funding for this project.

The Market Lane speed limit introduction debacle was mentioned, and it now looks like implementation will not be until 2023.

**Clir Blunt (8.12)** – Re the proposed recycling centre - MVV Medworth. He will be speaking against this at the Planning Committee Meeting next Monday, 7<sup>th</sup> of November, regarding the location near schools, infrastructure, and alternatives. The final decision sits with the Secretary of State.
